## Frequently Asked Questions

About Taxmann.com | Learning

#### What is Taxmann's Learning?

Taxmann's Learning is an endeavour to connect the experts with the learners seeking to upskill their knowledge in tax and corporate laws. This initiative uses three formats for knowledge-sharing: **Webinars, Workshops & Masterclasses.** 

#### Whom will I learn from?

The experts from diversified fields share their knowledge and insights on complex & new concepts, new developments, amendments, case laws, etc. These experts have at least 10 years of core experience in the respective field relevant to the session.

#### What will I learn?

A detailed agenda for an event is curated jointly by Taxmann's Editorial team and the speaker. The team ensures that the session's agenda should be such that it provides 360-degree coverage of the concept. In a workshop & masterclass, the experts share the background material, specimen, formats, excel templates, etc., to enable the user to implement the learning practically.

#### What topic is selected for the session?

We do the sessions on the concepts of Income-tax, GST, FEMA, Accounting Standards, IBC, SEBI, and so on. Our editorial team finds new and complex topics based on three factors:

#### Can I suggest a topic for the session?

#### How can I join the session?

All our events are live, interactive online sessions. Non-subscribers can watch the sessions live on our platform or Zoom; however, recordings will not be available to them. Subscribers can join the sessions live and also access the recordings later. Workshops and masterclasses are exclusively hosted on Zoom.

#### Will the videos work on all devices?

Our videos are best experienced on the latest browsers and updated devices. On a few older Android versions and some Apple devices, you may face playback issues. To enjoy uninterrupted playback, we recommend using Chrome or Firefox on a Mac, or a Windows device or an updated Android system.

#### What is the average duration of a session?

- The average duration of a webinar is 45 minutes to 60 minutes.
- The average duration of a workshop is 3 to 5 hours.
- The average duration of a masterclass is 15 to 18 hours.

#### Do I get a certificate for joining the session?

Yes, we provide a certificate to the users who join a workshop and masterclass session.

#### How do I know what workshops are included in my subscription?

Your subscription includes access to any 5 live or recorded events (within 3 months from the event date) at no additional cost. Once this limit is reached, you can purchase further live or recorded events at a 50% discount. Recorded events older than 3 months are available for unlimited access at no extra charge.

#### What access do I have to masterclasses in my subscription?

Masterclasses are not included in standard credits but can be purchased at a 50% discount.

#### Do I have free access to workshops and masterclasses in my free trial?

#### I see a mention of a 3-month waiting period for recorded events. Does this apply to all events?

No, this does not apply to all events. Webinar recordings are available immediately without any waiting period. After this limit, additional events can be purchased at a 50% discount. For masterclasses, live or recorded events (within 3 months from the event date) are available at a 50% discount. #### Does "1 device at a time" mean I can only ever watch on one device?

Not exactly. You can log in on multiple devices (e.g., phone, tablet, laptop), but you can only use one device at a time to watch live or recorded content. If you switch devices, just make sure to log out on the previous device or end that stream. This policy prevents unauthorised sharing and helps us maintain fair access for all.

#### I can't play the video on my device. What should I do?

If the video isn't playing, it might be because your device or browser isn't fully supported. Try switching to Chrome or Firefox on a Mac, or using a Windows or updated Android device.
